The Companies Act, 2016 which came into force on 31 January 2017 had abolished the age limit of directors. Hence, the shareholders' approval obtained on the reappointment of Mr. Lou as a director pursuant to Section 129(6) of the Companies Act, 1965 on 31 May 2016 had lapsed at the conclusion of the 32nd AGM. The Board had adopted the approach to appoint Dato' Abdul Ghani as a Director following his retirement pursuant to Section 129(6) of the Companies Act, 1965.
